

## KEY FEATURES OF THE PRODUCT

Groupama Axiom Legacy 21 invests in Tier 1 and Tier 2 'Legacy' bonds issued by major European financial institutions (mainly banks),

A Legacy debt is a subordinated debt that is eligible for inclusion in regulatory capital under Basel 2, but not under Basel 3. These securities are gradually disqualified during a transition period from 2013 to 2021, creating investment opportunities.

The fund aims to achieve a return above Euribor 3M + 3%. The fund exploits various performance drivers by investing in discounted bonds, long calls, fixed to fixed and securities issued by institutions whose credit quality is improving.

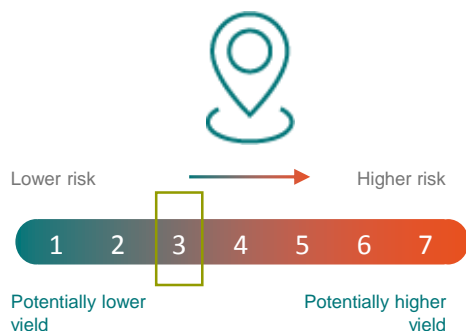
